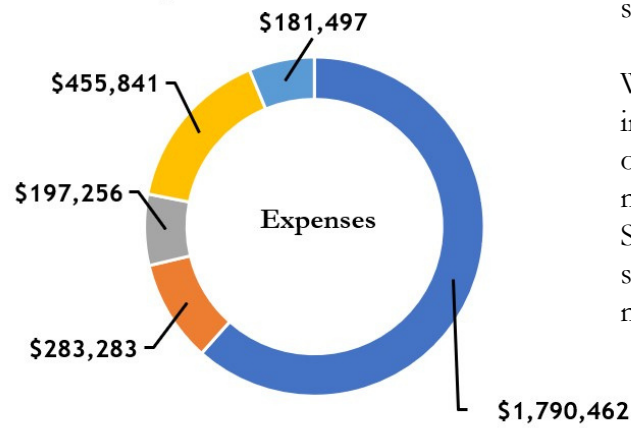
2022-2023 Fiscal Year (July 2022-June 2023)

We look toward the future and are including plans for capital expenses as our building ages and requires more maintenance. The Foundation and the School continue to work together to seek grants that enable us to live our mission.

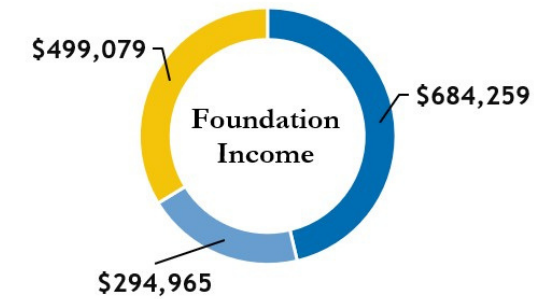

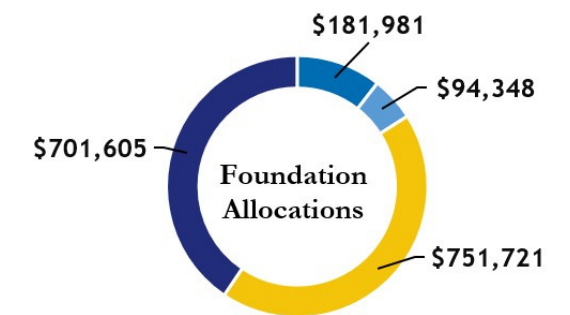
2022-2023 Fiscal Year (July 2022-June 2023)



St. Anthony Tri-Parish Catholic School Foundation is a nonprofit organization separate from St. Anthony Tri-Parish Catholic School and was incorporated in 2003 with the purpose of supporting St. Anthony Tri-Parish Catholic School for the long-term.

The Foundation is charged with fundraising for the immediate needs of the school while also building endowment funds that will support tuition assistance programs & sustain the school for many years.

The 2022-2023 school year begins. Our annual run fun/walk is revamped and moved to the school marking one of the schools most successful Amble events.

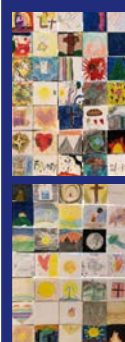

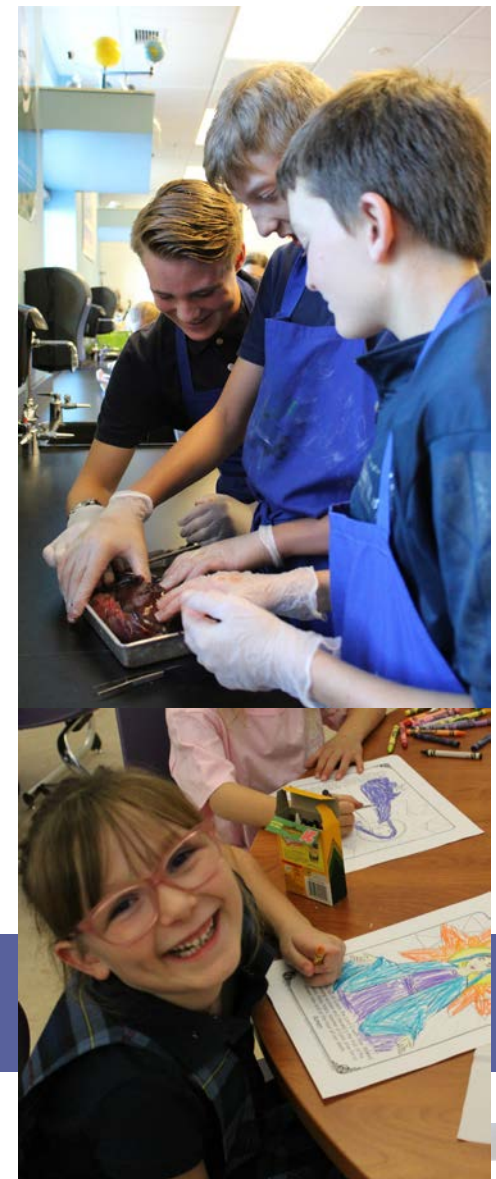
March also marked another successful Partners In Education event. Thanks to the amazing generosity of our community, we raised over \$530,000 in support of St. Anthony School.

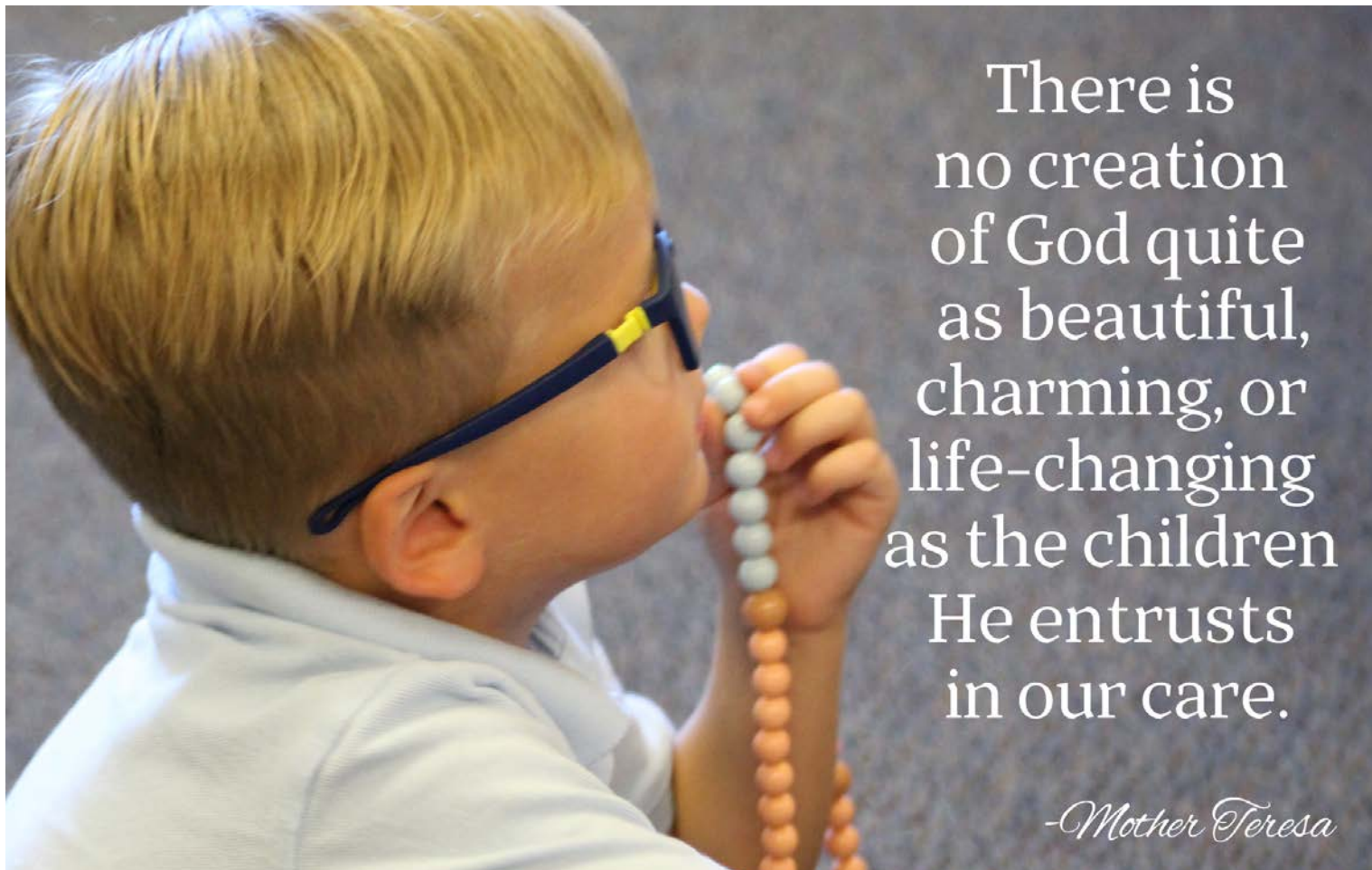
